4.A Approval of March 27, 2018 Olympia Metropolitan Park District Board Meeting Minutes

The minutes were approved.

4.B 2019 Preliminary Olympia Metropolitan Park District (OMPD) Budget Preview

Parks, Arts and Recreation Associate Director Jonathon Turlove briefed the Board on the proposed 2019 budget, highlighted upcoming projects, and discussed next steps toward budget approval.

Boardmembers asked clarifying questions.

The information was provided.

4.C <u>18-0846</u> Presentation of Annual Report by the Olympia Metropolitan Park District (OMPD) Advisory Committee Regarding Compliance of 2017 Funding Levels

OMPD Advisory Committee Chair Roger Horn discussed the work of the Committee and funding level compliance.

He highlighted two recommended amendments to the Interlocal Agreement for future Board consideration. He explained that currently the Committee is tasked with

determining compliance with Sections 4.1.1 (i) and (iv), but not (ii) and (iii). The Committee suggested changing the word "and" to "through" so that it determines compliance with Section 4.1.1 (i) - (iv).

Second is the emergency resolution regarding homelessness, which will affect the Interlocal Agreement by possibly taking \$500,000 in funding from 4.1.1 (iv).

Boardmember Gilman stated the OMPD Board took action at its March 27, 2018 meeting to amend the work plan to include items 4.1.1 (ii) and (iii) so the OMPD Advisory Committee has a more complete picture of revenues coming in.

President Cooper indicated the work plan was updated, but the Interlocal Agreement wasn't. There would need to be a public hearing held and agreement from the City Council and the OMPD Board.

President Cooper suggested a referral to the City Council Finance Committee to discuss establishing an Enterprise Fund that at year-end would keep all of the funds obligated to parks in the parks account. He will work with staff to draft a referral at next week's Council meeting. The Board agreed with the suggestion.

Mr. Turlove discussed the process and timeline for moving the two proposed changes to the Interlocal Agreement forward.

The report was received.

The budget proposed for 2019 represents an increase of \$281,898 over the 2018 budget while retaining the same rate of \$.54/1000 assessed value. This increased revenue will cover the increased cost of providing the same basic level of services including increased costs for maintenance and repair supplies, city utilities, and staffing costs.

OMPD Advisory Committee Recommendation to the OMPD Board

At our October 24, 2018 meeting, the OMPD Advisory Committee received a presentation on the proposed 2019 OMPD Budget. The committee supports the \$3,894,642 OMPD budget as proposed. This budget is estimated to result in no change to the current \$.54 per \$1,000 Assessed Value rate.

In reviewing the 2019 Preliminary Capital Facilities Plan, the proposed capital budget includes 11% of the City's total expected revenue as per section 4.1.1 (i.) of the Interlocal Agreement as well as \$2,945,000 for park land acquisition (including \$770,000 for bond repayment), which meets the requirements per sections 4.1.1 (ii., iii., and iv.). It therefore appears that the proposed budget is compliant with all requirements of the Interlocal Agreement.

Our committee will be reviewing OMPD's 2018 expenditures in the spring of 2019 and will provide a report for your review at that time.



Background and Analysis:

The Olympia Metropolitan Park District (OMPD) is required to adopt a property tax levy resolution and file a levy certification with the County by November 30, 2018.

A public hearing on revenue sources, including property tax, is required prior to the adoption of the property tax levy (RCW 84.55.120). The proposed OMPD 2019 revenue only includes property tax. Notice of the hearing was published on October 22 and October 29. The levy is based on the budget, which includes amounts to be paid to the City of Olympia and administrative costs.

Staff will present the final budget. The Final 2019 OMPD Budget is \$3,894,642. Based on the assessed valuation of the District the projected levy rate per \$1,000 is \$0.54.

The 2019 estimated levy rate is the same as the 2018 rate at \$0.54 per \$1,000 of assessed property valuation. The annual cost on a single-family home valued at \$350,000 is \$189 per year or \$15.75 per month.

Options:

- 1. Hold a public hearing. Close the hearing and direct staff to prepare an Ad Valorem Tax Resolution in the amount of \$3,894,642 for OMPD Approval on November 13, 2018.
- 2. Hold a public hearing. Close the hearing and direct staff to prepare an Ad Valorem Tax Resolution in a different amount.
- 3. Hold a public hearing. Do not close the hearing and schedule a special meeting to continue the public hearing.

Financial Impact:

Provides \$3,894,642 in property tax revenue to the Olympia Metropolitan Park District
