#### **Background and Analysis:**

A 2015 Thurston County Economic Development Council Survey identified parking as a significant barrier to economic growth in Downtown. Downtown Strategy, adopted in 2016, called for an updated Parking Strategy to support its vision and goals. The draft Parking Strategy addresses the parking needs of Olympia today, with wide ranging recommendations to better manage parking resources. These recommendations are the result of occupancy analysis, stake-holder workshops, public surveys, and informed by the parking industry's best practices.

Strategy 1	Tools to Mange the Parking Program and Enforcement and Improve Customer Convenience
	(1.1) Implement the NuPark Parking Management System and License Plate Reader (LPR) system to improve enforcement and ongoing data collection to support parking management and implement Pay-by-Phone system-wide as part of this project
Strategy 2	Improve On-Street Parking
	(2.1) Prioritize short-term parking in the Downtown core and adjust pricing if necessary in order to manage to the 85% rule to ensure the right spot for the right person.
	(2.2) Implement paid parking and enforcement on Saturdays between 9AM and 5 PM in the Downtown core.
	(2.3) Convert 9-hour meters in the Downtown to short-term visitor parking.
	(2.4) Collect data and monitor parking demand to analyze the impacts of 15 minutes of free parking and free holiday parking

Public Works Transportation Staff will provide a briefing on two major projects that are underway:

- Transportation Master Plan: The plan will define the long-term development of the transportation system for all modes of travel and the associated funding strategy. At the meeting, staff will brief the Commission the status of the plan's development and recent public engagement.
- Downtown Street Improvement Projects: Design is underway for the improvements to Legion Way and Franklin Street, anticipated for construction in 2020. Staff will provide an update on the scope of these two near-term projects, as well as long-term plans for improvements on Capitol Way and Washington Street.

The total cost of the Transportation Master Plan development process is \$300,000, funded through a variety of City transportation funding sources. The Legion and Franklin projects are estimated at \$6.3 million and will be funded through a combination of City transportation funds and grants.
