Additional Public Comment, Revised Conditions of Approval

Following issuance of the public hearing notice, the City received a comment letter on December 2, 2019 from Brad Beach of the Nisqually Indian Tribe. This letter reiterates comments initially sent on June 7, 2020 requesting archaeological monitoring during site disturbing activities in addition to an Inadvertent Discovery Plan. The June 7 letter is included as Attachment 15 of the packet; the December 2 letter will be submitted into the record during tonight's hearing.

The City's Historic Preservation Officer (HPO), Marygrace Goddu, reviewed the Tribe's initial comments and in turn recommended that a monitoring plan be required as a condition of approval. This language was inadvertently omitted from the staff report, and as such, staff recommends that Condition #13 be replaced with the following language:

A Monitoring and Inadvertent Discovery Plan shall be prepared and submitted with the construction permit application(s). The plan shall provide for professional on-site monitoring during ground-disturbing activity, to include Tribal representatives if they desire. The plan shall also describe the actions to be taken by the project proponent and site crew in the event that archaeological resources are uncovered during the course of project work. The plan shall be completed and approved prior to issuance of any construction permits or commencement of any site work, and a copy of the plan maintained on site throughout construction. OMC 18.12.140

The HPO will be available at tonight's hearing should you have questions regarding cultural resources for the State and Water project.

Hi Cari.

I reviewed the Staff Report prepared for the Hearings Examiner and am concerned that item #13 does not fully reflect the required project condition.

As written, the staff report omits the monitoring requested and requires an Inadvertent Discovery Plan only, which will be inadequate. Tribal and DAHP reviewers indicated that a level of monitoring is needed during ground-disturbing activity at this site. The Historic Preservation Officer concurred with this direction and has requested that a Monitoring and Inadvertent Discovery Plan be in place prior to construction, and followed during all ground-disturbing activity.

There are three components to the cultural resources conditions for this permit:

- Complete a Monitoring and Inadvertent Discovery Plan
- Complete a professional archaeological desktop survey of the project area
- Notify and update Tribal contacts re construction schedule for ground-disturbing activity at the site, and allow them to be present on site if they desire.

Please let me know if additional clarification or detail is needed.
