10. In your own words, what is the role of an Olympia Planning Commissioner?

Citizen-run planning commissions are a new concept for me. The large East Coast cities where I've spent most of my life did not have citizen-run boards. Washington, on the other hand has formalized them in state statute (RCW 35.63.070). I'm for it. On the other hand, having participated in staff-led commissions in places such as Boston and Philadelphia, I learned how vitally important professionalism and fairness are to the job. Olympia has 50,000 people. Only nine serve on the Planning Commission. Inevitably, those nine members will be higher-income and have the privilege to spend their spare time doing what to many others resembles paid work. It's the role of a Commissioner, therefore, not to act in their best interest, but put themselves in other shoes, especially those without the means to participate in the same manner.

11. What interests you most about community planning?

Just from applying, I am learning that "community planning" and "city planning" are not the same thing. City planning is a prescription of codes and manuals to optimize a city's performance. Community planning is about deconstructing why we break the rules. These are two very different skillsets, and while I have familiarity with the rules and how we govern ourselves, I want to learn more about why we break the rules.

12. What skills would you bring to the work of the Planning Commission and what do you hope to learn?

My previous skills lie squarely in the city planning realm and not community planning. To address this, I want to learn more about how planning impacts people, both directly and indirectly. When most people live their daily lives, they are not doing so in accordance with how planners prescribe. For example, people may be more likely to overstay parking time limits in one area. Certain parts of town may attract younger people, or more rental applications. These are indications of rules and regulations that aren't fitting people's needs and planning can't proceed unless we know why.
