4. ANNOUNCEMENTS

6. BUSINESS ITEMS

A. LBA Woods Presentation (Brian Faller)

Mr. Brian Faller and several members of the LBA Woods Park Coaltion presented a powerpoint on the need to purchase open space properties surrounding LBA Park. The properties are currently slated to be developed with large housing developments. The Coalition advised the Committee and staff to evaluation potential uses of the properties to address community needs and to contact owners regarding purchase options.

Bicycle and Pedestrian Advisory Committee (Jesse Dwyer): BPAC is currently looking at bicycle parking code and 4 bike spots are required at parks.

8. OTHER TOPICS

The Committee had a short discussion on the Isthmus. They asked Councilmember Jones to request the Citizens Advisory Committee (CAC) to include a member of PRAC on their committee.

The 2014 budget is the first budget with no FTE cuts. The budget includes an addition of .25 FTE for Urban Forestry and \$100,000 for wayfinding signs for bicyclists on less volume streets.

The Port is installing a new fueling facility for boats along with with \$4.5 million dredging project.

Angie Regensburg has a new book out called *Explore Olympia Tumwater and Lacey*.
