## 6. BUSINESS ITEMS

**6.A 14-0288** Update on City of Olympia Downtown Project

Discussion only:

Mr. Wilson gave a presentation on the Downtown Project Phase III. He described the multi-directional approach focusing on a variety of key projects in four identified categories: Clean, Safe, Economic Development, and Placemaking. He asked for feedback from the Commission on: freeway signage for a Historic Downtown exit, building color selection for painting downtown, and historic background information for alleyway murals.

**6.B 14-0287** Discussion of Revised Scope and Timelines of Certified Local Government Grant

Discussion only: Ms. Sadlier discussed the changes to the scope of work and timeline for the Certified Local Government (CLG) grant for the survey of mid-century properties. Commissioners gave supportive feedback on the proposal.
