A RESOLUTION OF THE OLYMPIA METROPOLITAN PARK DISTRICT ("OMPD") AUTHORIZING DESIGNATION OF THE CITY OF OLYMPIA ADMINISTRATIVE SERVICES DIRECTOR AS OMPD TREASURER UPON COUNTY TREASURER APPROVAL

WHEREAS, RCW 35.61.180 states that the county treasurer is the ex officio treasurer of a metropolitan park district but that such district may designate someone other than the county treasurer who has experience in financial or fiscal affairs to act as the district treasurer if the board has received the approval of the county treasurer to designate such person; and

WHEREAS, RCW 35.61.180 further states that, if the board designates someone other than the county treasurer, the district must purchase a bond from a surety company operating in the state that is sufficient to protect the district from loss; and

**WHEREAS**, the Olympia Metropolitan Park District Board ("OMPD Board") wishes to designate the City of Olympia Administrative Services Director as the Olympia Metropolitan Park District Treasurer;

## NOW, THEREFORE, THE OLYMPIA METROPOLITAN PARK DISTRICT DOES HEREBY RESOLVE:

- 1. The OMPD Board wishes to designate the City of Olympia Administrative Services Director as the Board Treasurer and hereby authorizes the OMPD Board President to send a letter in substantially the same form as the one attached as Exhibit "A" to the Thurston County Treasurer seeking approval to make such designation.
- 2. Upon the date approval is received from the Thurston County Treasurer, the City of Olympia Administrative Services Director shall be considered officially designated by the Olympia Metropolitan Park District Board as OMPD Treasurer.
- 3. After such official designation, the Board President is hereby authorized to obtain a bond from a surety company operating in Washington in an amount sufficient to protect the district from loss.
