They requested staff to gather the following information:

- City job classifications including salary
- City budget
- Historical cost of living adjustments provided to independent City employees from 2008 through 2017
- Cash value of medical benefits offered to independent City employees including "opt-out" incentives
- Cost of comparable medical plans to plans offered to City employees
- Salary compensation for Not-for-Profit organizations
- Salary compensation for Board Members of private corporations
- Department of Retirement Services information for Elected Officials
- Full-Time Equivalent calculation for current City Council
