

# Revised Request for Proposals (RFP)

# **Cultural Resource Survey for Priest Point Park**

# **Project Summary:**

The City of Olympia seeks the services of a qualified consultant to conduct a reconnaissance-level cultural resource survey for Priest Point Park. The budget cap for this project is **\$23,000.00**.

# **Project Background:**

Priest Point was established as a City park in 1905 but its story as an important gathering place for multiple tribes is known to long predate this local designation. Located along the shores of Budd Inlet, the park is over 250 acres of mostly undeveloped land, including two fish-bearing streams. This much-loved park was listed on the Olympia Heritage Register in 1987 for its historical significance. DAHP's WISAARD shows that there is a very high risk of uncovering archaeology within the entire park, but thus far there are only five recorded sites and one survey identified in the database. With the recent exposure of cultural resources in the park due to erosion and capital improvements, the City recognizes the need for a professional study to provide foundational knowledge to help guide its long-term stewardship of this jewel of a public park and cultural landscape.

# **Project Scope:**

This survey will cover the full geographical extent of the 250-acre park. Because protection of the park's limited number of standing buildings and structures is already addressed under the local register designation, the focus of this survey will be on pre-contact and other tribal cultural resources; while not anticipated, any substantial historical archaeological resources encountered will also be addressed.

Research methods will include: desk-based analysis of maps, historical documents, and previous surveys; technical and verbal coordination with Tribal Historic Preservation Officers (THPOs) or delegated cultural resources representatives; and pedestrian survey of the park with a limited number of shovel probes.

#### Additional considerations:

- This project has been initiated to support City's management of the park and is not associated with any formal regulatory processes. It is currently anticipated that a future project will involve the development of a cultural resource management plan following the completion of this survey project; should funding be secured, this second phase would be addressed in a new RFP.
- The bulk of the funding for this project comes from a Certified Local Government grant provided by the
  Department of Archaeology and Historic Preservation (DAHP). Written project deliverables must meet DAHP
  requirements.
- Multiple tribes have an interest in Priest Point Park. Demonstrated experience working with the Tribal
  Historic Preservation Officers (THPOs) of the Nisqually Indian Tribe, Squaxin Island Tribe, and other regional
  tribes is strongly preferred.
- The City's Historic Preservation Officer will make initial contact with the THPOs of the Squaxin Island Tribe and Nisqually Indian Tribe to initiate consultation and help coordinate tribal communication on the project.
- City staff dedicated to providing background information and other project support include the Historic Preservation Officer, the Parks Stewardship Supervisor, and a GIS specialist. Olympia Heritage Commissioners who meet relevant U.S. Secretary of the Interior's Professional Qualification Standards (SOI Standards) are also available.
- Lead technical member(s) of the project team must meet the SOI Standards for archaeologist. A professional archaeologist must be present in the field at all times to supervise and support crew members who do not meet the SOI Standards for archaeologist.

## **Project Deliverables:**

- One comprehensive, illustrated report which includes a description of research methods, context, maps, analysis with justification, summary table of all potentially significant features surveyed with NRHP eligibility recommendations, and recommended next steps for the City's use of the survey's data;
- DAHP WISAARD site forms (estimated at 10-20); and
- Two presentations at regular Heritage Commission meetings, the first serving as project kick-off and the final meeting being a presentation of findings.

- **References** a minimum of three names and contact details [*limited to 1 page*].
