We are submitting a presubmission conference request in order to discuss and present the following:

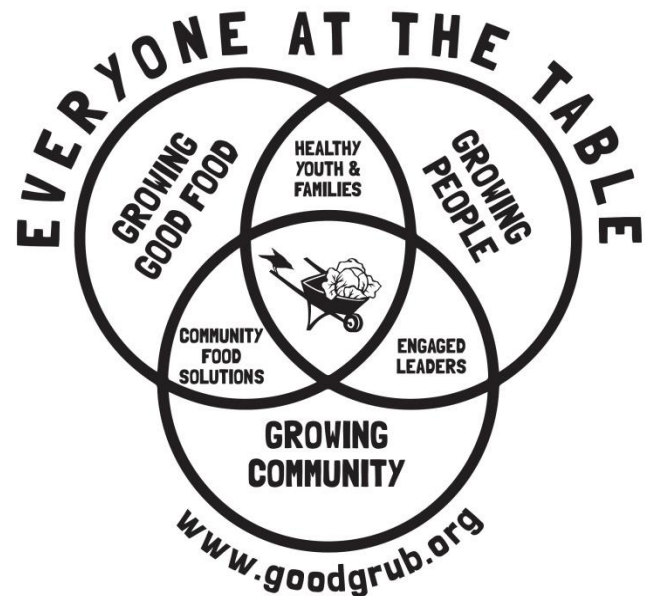
1. Renewal of GRuB's Conditional Use Permit and potential adjustments to existing permit.
2. Possibility of remodeling the existing GRuB Farmhouse Kitchen to be commercially certified.

1. Renewal of Conditional Use Permit

It has come to our attention that our CUP expired at the end of 2017 and we would like to renew our CUP. In the 10 years since the original CUP we have grown both in staffing and in community member engagement with the organization. We are requesting the opportunity to amend the CUP to reflect this growth. Specifically we would like to discuss adjustment of operating hours and increasing the number of people allowed to be on-site during operating hours.

2. Commercial Kitchen Remodel

In order to create opportunities for production of value added products from the farm we are exploring remodeling the existing kitchen so that it can be commercially certified. This will not change the number of people on-site or the layout of the existing kitchen other than the addition of a 3-bin sink and commercial refrigerator. We do not plan to process or cook meat in the kitchen.
