Franklin & Legion Pedestrian Improvement Project Public Art Component Presentation

Ms. Stimson kicked off the presentation with an overview of the Franklin & Legion Pedestrian Improvement Project, followed by Ms. Williams who highlighted planned infrastructure improvements referencing applicable Downtown Strategy Character Areas. Within that framework, Ms. Sollod shared her public art concept loosely titled "Olympia in Space and Time," utilizing in-pavement granite markers that reference Olympia's geographic characteristics, such as latitude/longitude, GMT location and past and present area names, along with decorative screens to delineate and soften adjacent surface parking lots. Discussion with the Commission followed, leading to productive feedback for the team.

Commissioners engaged in general discussion of Music Out Loud, and the OAA's efforts to pair artists with vacant downtown storefronts (the project was recently awarded Grants to Arts Organizations funding match for the project).

West Bay Art Crossing Artist Recommendation

Ms. Johnson shared that finalist interviews took place on Wednesday, January 9, and noted that jurors were impressed by all three finalists. Their recommendation of Milo White and Lin McJunkin, is due to their demonstrated strong synergy as a team, solid technical understanding and creative vision, all of which was reiterated among their references.

In discussion, Commissioners suggested asking the first artist team to mentor the next, and so on, as with the Poet Laureate program. They also began to think about whether artists or teams who have been selected in the past would qualify to apply again. Chair Grisham suggested the topic be taken up at the spring retreat.

Commissioner Hicks moved to approve the artist recommendation and forward to Council, seconded by Commissioner Williams. The motion passed.
