Hello Paula, I see that you're the lead planner on the capital high school performing arts center land-use application project, file number 18 – 3543. My name is Ocean, and I live at 2613 Conger Ave., immediately adjacent to the Eastern property line of capital high school. I have lived here for 20 years, and I am a disabled man. I use a wheelchair, and I have some grave concerns about the proposed action at the north-east corner of their site plan. As you can see, they are required to provide some additional parking, and their designer/architect has decided to locate that at the north-east side of their property. My understanding is that this will require them to building a retaining wall in the hill as well as an additional access drive at the extreme north-east corner of their property, connecting that parking lot with Conger Avenue. I am concerned with how this will impact my home, as well as my safety, as they want to have a driveway right next to my house. I have lived with this high school for 20 years, and I know how inexperienced high school drivers are. They'll often drive in an unsafe manner, accelerating fast and not paying safe attention to the road. The insurance policies for new teenage drivers are so high precisely because of their dangerous safety records. I am wondering how much of a voice I actually have in persuading you, as the lead planner, to have the applicant adjust this plan so that it does not impact me so severely. They certainly have more undeveloped property at the Southern extent of that parking lot, which could be expanded if further parking is required. I see that you invite written comments by September 10 – does this email count as a formal written comment, or do you require a physical letter? And how much does a formal written letter of concern actually impact approval of this project? I'm wondering if you and I can have a meeting to discuss these concerns in person. If you work down at City Hall, I would be happy to make an appointment with you. Thank you for taking my voice into consideration, Paula. -Ocean
