4.A [20-0282](#) Approval of Entry Level Police Officer Register

Ms. Camus reported that forty-four candidates were invited to the phase 1 suitability assessment. Sixteen participated in the phase 1 suitability assessment, and four passed. Four candidates were invited to oral interviews, three participated and two successfully passed the oral interviews.

Six candidates were female and thirty-eight were male. Thirty were White/Caucasian, two were Asian/Pacific Islander, four were Hispanic/Latino, one was African American, and seven were two or more races.. The interview panel consisted of OPD Officer Kory Pearce, OPD Officer Sean Lindros, and Police Service Specialist Angela Johnson (the scheduled community member called in sick).

Two candidates passed the phase 1 suitability assessment and the oral interview and have been placed on the register in accordance with scores of 81.43 - 86.27.

Commissioner Soule moved seconded by Commissioner Callner to approve the Entry Level Police Officer Register. The motion carried with the following vote:
