

Shoreline Master Program - Periodic Review

What is a Shoreline Master Program?

A Shoreline Master Program (SMP) is a set of written local land-use policies and regulations that guide the use of shorelines. The SMP applies to both public and private uses of shorelines. The main purposes of the SMP are to protect natural resources for future generations, provide for public access to public waters and shores, and plan for water-dependent uses.



In the City of Olympia the SMP applies to Lake Louise, Capitol Lake, Ward Lake, Ken Lake, Chambers Lake, Percival Creek, Black Lake Ditch, and the marine shoreline areas.

What is the "periodic review" of the SMP?

Every eight years, counties and cities must review the SMP to ensure it remains consistent with changes in state law, the adopted Comprehensive Plan, and any changes in local circumstance. The periodic review is not as involved as the "comprehensive update" that Olympia completed in 2015. The comprehensive update was a major rewrite of the SMP that took several years to complete. This review is expected to be complete by June 2021. Ecology provides grant funds to help cover costs associated with conducting the review. The City received a grant for \$28,000 to conduct the review and adopt revisions.

Gap Analysis

The City used the Washington State Department of Ecology (Ecology) checklist to identify and evaluate any needed revisions. The report was posted online and the public was invited to submit comments. Primary areas to be addressed during these updates include revisions to reflect changes in Ecology rules; updating wetland buffer widths to align with the newest Ecology guidance; integrating the City's Sea Level Rise Response plan; adding references to shoreline restoration assessment reports; and addressing issues identified by staff and stakeholders as needing clarification or improvement. The SMP and any revisions to it must be approved by the City Council and the Department of Ecology.
