## <u>20-0769</u> Creative District Land Use Planning

Ms. Goddu explained that she was part of a team of City staff looking at barriers in code and regulations that might be hindering housing as well as other types of development. She shared that the Creative District currently has two zones within its boundaries: waterfront and downtown business. Explaining how important the language is in code, she shared some different approaches used to define "creative industry," as part of her own process of providing language for Olympia's code. Commissioners provided feedback.
