Hello Nicole Floyd,

We are Kayana & Richard Hoagland. We live just a block or two from Ingersall Stadium and have lived here 12 years.

We are opposed to lifting the restrictions place on Ingersall Stadium at this time for several reasons and here are a few:

- 1. NOISE. The city is currently working on road improvements to slow traffic on Henderson Blvd. The current status of noise from traffic on Henderson is unacceptable. The city installed speed bumps to temporarily slow traffic approaching the Henderson/Carlyon intersection, but the logging trucks and pull-behind trailers of yard maintenance folks, boaters, RV's, and other longer-than-usual vehicles cause a severe racquet because they can not or choose not to slow down enough to navigate the turns.
- 2. COVID-19. Due to Covid-19 and the Coronavirus, this is an unprecedentedly quiet year for foot traffic, car traffic, Ingersall Stadium usage (noise, lights, band). The restrictions were imposed for good reason and have been previously presented for--and rejected --for lifting. This would be an atypical year to make a decision like lifting the limitations.
- 3. REMOTE LEARNING. In the small neighborhoods on Centerwood Drive SE, Fir Street SE, McCormick St SE, Lybarger St SE, Carlyon Ave SE, Central St SE, Boundary St SE, Pifer Rd SE, many houses are currently for sale or have been purchased in the past year. With schools being in the current phase of remote learning since early spring, these new neighbors are not even in a position to weigh into this public comment period.
- 4. SAFETY. The traffic on Henderson Blvd SE, North St SE, and Cain Rd SE, are already out of control in terms of speed and safety. Many drivers are being irresponsible and driving across the roundabouts instead of around them, screeching their tires, hitting the guardrails on Henderson, and driving excessively fast, especially after dark. The police have been asked by the Neighborhood association and the NEXT-door APP to focus on correcting this situation, but neighbors are still complaining.
- 5. ACCESS TO TRACK. Community and neighbors have access to the track during times the stadium is not being used. This would have the impact of decreasing the availability of the track to local neighbors which is part of the Ingersall agreement.

Most of these concerns address the currently unacceptable noise level for people living in the neighborhood and safety issues involving the road construction, roundabouts, and excessive speeding all the way down Henderson through Watershed Park.

Andrew Beagle, Transportation Engineering Supervisor, from the Public Works Department, recently came door-to-door throughout our neighborhood apologizing for the excessive traffic noise and letting home owners know that the road improvements project is not completed, it is only delayed due to Covid-19 and funding issues. The city plans to eventually REMOVE the speed bumps leading up to the roundabout on Carlyon and Henderson, however there is no immediate time-line for this. Hopefully they can install traffic devices so that all the logging trucks that use this thoroughfare and all the trucks pulling trailers do not drive over the speed bumps and over the roundabout lids. These are dangerous habits and it happens consistently, to the point that the city has installed noise-measuring devices and found the noise levels excessive.

Please, <u>do not add</u> to the problems our neighborhood is already having. WAIT to consider this proposal until the already bad and uncontrollable traffic on North ST SE and Henderson Blvd SE have been remedied. Current projects and changes should be completed before considering a modification to the restrictions to Ingersall Stadium. To approve this proposal with all the unusual and high profile SAFETY considerations mentioned above is NOT a variance we think the planning department should approve.



Dear Mr. Lindsay:

We are contacting you because of the 11 speed bumps installed in June, at the intersection of Henderson Blvd and Carylon Street. The speed bumps are on both sides of the north bound lane on the east side of Henderson Blvd.

Although we applaud your department's mitigation efforts to reduce traffic speeds at this intersection, these speed bumps have made our back yards uninhabitable. The sounds of any vehicle larger than an SUV going over any of the speed bumps creates such noise pollution that it has affected the quality of life of the several families who live along Henderson Blvd across from Pioneer Elementary

For instance, on June 26th, I attempted to host a book discussion group outside in my back yard. We were social distancing as required by Covid 19 restrictions. Our group gave up and stopped the discussion because we could not hear each other. (We could not meet in my home, because many members are over 60 and did not want to risk contagion in an enclosed setting.)

On July 4th, at 6:36 AM, my husband and I heard the loudest crash we ever heard outside our home. We rushed out to see if there had been an accident, but it was just a semi going over the speed bumps. The Hoaglands have been awakened by loud crashes in the middle of the night. And the Hamblets can feel their house shaking when big trucks crash over the speed bumps.

On July 23rd, I was working in my garden between 8:38 and 9:08 am. I counted 10 large trucks in that half an hour that crashed and banged over the speed bumps. Two trucks slowed down and passed through the round about area without making a din. This unscientific count means that there was a truck every 3 minutes banging over the speed bumps going through the intersection. Henderson Blvd. is on a truck route and many logging trucks pass by every day, as do pickups pulling landscaping, boat or other trailers. These smaller vehicles also bang and crash over the speed bumps. Related to the noise of the semi's going over the speed bumps are the semi's use of their brakes, either loud squealing or "jake" brakes as they gear down and then gear up going through this area.

If transportation engineering did a sound study at our intersection, I believe that you would find the decibels created by vehicles crashing over the speed bumps and applying their brakes are of an unacceptable intensity.

We wonder if these speed bumps could not be relocated to an area south of the Carylon Street/Henderson Blvd intersection, at the wooded triangle of land that the Olympia School District owns. On the west side, across Henderson Blvd is the Olympia School District's playing fields. Thus, no homeowners would be affected by the noise created by speed bumps located here. Traffic would be slowed down before it gets to the Carylon Street/Henderson Blvd intersection and pedestrian/school crosswalk.

One of the neighbors signing this letter also suggested that a digital speed sign be installed similar to the one at the south end of the Watershed Park on Henderson. Again, a digital speed sign might be located on the east side of Henderson Blvd at the wooded triangle of land that the Olympia School District owns. This would alert drivers of their speed before they reach the round about and pedestrian/school crossing.

We would be most happy to hear from you or your department about this pervasive and inordinately obnoxious noise and air pollution issue affecting our neighborhood and families.

There are three upcoming events:

- Neighborhood meeting Wednesday. Intended to introduce the project to the community and answer questions about the proposal.
- SPRC meeting Oct. 21. To forward the decision to the Hearing Examiner. Since the Hearing
 Examiner created the condition of approval, it is the Hearing Examiner that would be the correct
 review authority.

• Hearing: Nov. 9 – For the Hearing Examiner to review the proposal and consider the community input.

Sir,

Let's hold off on school district stadium expansion. After considering everybody's thoughts on the city proposal to rent out the district stadium at Olympia High School to all types of user groups, this is what I've concluded and read between the lines and information provided.

The Southeast Olympia neighborhood stands to lose far more than it gains if Olympia High School (OHS) opens up the stadium for non-district and non-student use.

Yes, the district will make more money from the private commercial use of school grounds. However, southeast residents will pay the price.

There was valid reason with the restrictions now and in the future...

1. The trade off might be worth it if no other facilities existed. However, one does and it was purposefully designed for commercial use and NOT located in a residential neighborhood.

See the Lacey-Thurston County Regional Athletic Complex (RAC) bills itself. I don't find it positive for our neighbors.

Regarded as one of the finest outdoor sporting venues in the state, this 100-acre facility features spectacular views of Mt. Rainier, five softball / baseball / fast pitch fields and six regulation-size soccer / football / rugby fields, as well as picnic and outdoor event facilities, playgrounds, concession stands, two miles of walking trails, family restrooms and much more. In other words, the Lacey RAC is already meeting the need for commercial outlets for adult and youth sports, political rallies, concerts and community events.

Even closer to OHS is Pioneer Park, which the City of Tumwater already rents out. Unlike OHS, it has lots of parking and is NOT surrounded by homes.

2. Before SE residents allow the city to approve more OPTIONAL traffic, noise and people, let's wait until more of this area's undeveloped areas are turned into homes. The Briggs branch of the YMCA will soon be engulfed by apartments, townhouses and condominiums. Not saying this is bad, just acknowledging the extra people it will attract. Same for the subdivision already approved for the corner of 22nd and Cain Road. Besides actively promoting development of all vacant lots, the city has also approved new zoning that will allow more residential development within already developed neighborhoods.

- 3. Again, let's not make an OPTIONAL decision to add more traffic at a time when most people and children are remotely working from home and not out on the roads. Now is NOT the time to realistically assess normal traffic patterns.
- 4. I'm concerned about the birds and wildlife that use the triangle-shaped pocket forest located along the Henderson-North intersection (see image). The school district owns this site. Though not part of the city's current proposal, I think the possibility exists that the district would turn this forest remnant into a paid parking lot if stadium use is expanded.
- 5. The SE neighborhood is already noisy: Day and night military and helicopter fly overs, vehicles speeding and racing on North, Henderson and Cain streets and vehicles "burning rubber" and "doing circles" in the OHS parking lot during the middle of the night. Do we really need more OPTIONAL noise right now?
- 6. And, finally, SE residents don't know the full extent or consequences of a stadium expansion since the city and district are introducing each phase of its long-term proposal in baby steps. Is it the intent of These two governmental agencies to trample the Neighbor hoods peaceful environment, quality of life

I value your input and understand that the zoom webinar format was new, different, and a bit awkward. I think there is room for improvement regarding what type of online meeting is set up and what functions are available in that format. It's something I will work with the planning team on, so that we can make the meeting feel more comfortable.

The part of your comment below that I am a little confused by is that you feel the meeting ended abruptly. Neighborhood meetings rarely extend beyond the one hour they are scheduled for. This usually gives enough time for the functional purpose of the meeting – provide early information and allow for questions. In my experience, when the neighborhood meetings extend much beyond an hour the conversation starts to move away from inquiry and into opinion. Given the zoom format, it seemed reasonable to give extra time, and we did. I made a concerted effort to be clear from the onset about the anticipated amount of time for the meeting. Nevertheless, the meeting continued for a full two hours. The majority of which was dedicated to question/answer. Nicole Floyd;

These are my comments regarding the Olympia School District's proposal "Ingersoll Use Restriction Modification" File Number 20-3702 (Notice Mailed Sept. 23, 2020).

The current proposal from the Olympia School District (OSD) states that it is "to modify the user groups allowed to use Ingersoll Stadium". However in fact, the proposal would not simply "modify" the Land Use Approval of 2004, it would scrap a critical condition of that Hearing Examiner's 2004 ruling. That ruling was not appealed. That part of the Hearing Examiner's ruling from 2004 (case number 03-2397 included by reference) was reaffirmed by another Hearing Examiner in 2013 (case number 11-00159, included by reference) who referred to both rulings as "final". The 2013 Hearing Examiner's ruling was also — not appealed. By limiting the land use to specific groups, the Hearing Examiners provide some level of protection to the people who live in the residential zone nearby the OSD sports facility.

One of Olympia's Municipal codes (OMC) speaks to residential zones (OMC 18.04.020, included by reference) which provides the City's overall purposeful definition of what considerations must be taken into account for residential zones.

Notably section A(3) "To maintain or improve the character, appearance, and livability of established neighborhoods by protecting them from incompatible uses, excessive noise, illumination, glare, odor, and similar significant nuisances." and section B(4) "Residential 4-8 Units per Acre (R 4-8). To accommodate single-family houses and townhouses at densities ranging from a minimum of four (4) units per acre to a maximum of eight (8) units per acre; to allow sufficient residential density to facilitate effective mass transit service; and to help maintain the character of established neighborhoods."

By removing the Land Use condition that limits which user groups that are allowed to use the sports facility at Olympia High School (OHS), the City would take our residential zone back to the very real possibility, (in my view, the very real <u>probability</u>) of OSD abuses of the "character, appearance, and livability" in our residential zone. I know that OSD claims that their internal policies will provide us with those protections, but that promise has been broken so many times by the OSD itself, that it cannot be, and should not be taken as truthful or functionally useful in that regard. OSD can ignore or change its internal policies with relative ease. Reading the Hearing Examiner's 2004 ruling in case number 03-2397, and its supporting documents reveals he was convinced of this as well, and it was a strong reason he decided he needed to condition the OSD's Land Use Permit. The City, and the City's Hearing Examiner

have a responsibility to protect the "character, appearance, and livability" (OMC 18.04.020) for the people who live in the neighborhoods nearby the OSD's much expanded sports facility in the residential zone in which the Olympia High school is imbedded.

The OSD removed Ingersoll's natural grass field and replaced it with an artificial turf field at great cost in 2004 and an Advisory Committee at that time estimated that the new field use, could be increased from 100 to about 500 events per year, day or night, all year. Now that the OSD has installed a second artificial turf for football and multi-use at the same facility, one can do the math and expect that usage of the facility could double, or more, depending on user groups allowed to use the facilities. The frequency of use will obviously increase, if only because there is now a second artificial turf field right next to the Ingersoll Stadium. The OSD does not need the capacity to support unlimited user groups to carry out its educational mission, consistent with its educational purpose. OSD has no cogent rational that would override the need to protect the closely surrounding residential zone. The Olympia High School, including its athletic resources is supposed to be an educational facility, not a public playground. OSD's piecemealed expansions of the High school's sports play fields has been called "a community resource" by OSD and its sports loving proponents. That is a clear admission that OSD continues to deliberately exceed the educational purpose of the school's sports facility into that of a public sports park. The City should not be complicit with such an effort, but should diligently protect the residential zone in which the school is sited.

According to OMC 18.04.020(CC) Schools (included by reference) in its section 1, recognizes the importance and intent of the City to protect the residents of adjoining properties to schools. Removing the non-district, private user restrictive condition on the Land Use Permit, will work to the detriment of the residential zone in which the Olympia High school is sited.

In a "Neighborhood Meeting" held on the online, Zoom conference platform, arranged by the City Planning department, OSD and others stated that the Ingersoll sports facility was "maxed out" meaning it already is used at or very near full capacity, with the current Land Use conditions. Yet the OSD also says that with the addition of a second artificial turf field right next to the Ingersoll stadium, that there will be no significant increase in use, and no significant environmental impacts. Such comments are both manipulative and deceptive, in that they ignore the expected and perhaps desired active use of TWO artificial turf fields by unrestricted user groups. While the current discussion about this important issue tends to be focused on the Ingersoll Stadium and the field to the east of it, the Land Use Permit may encompass a much larger area of the OSD property. That being the entire Olympia High School site, its various fields, structures, parking, drainage, etc. that are part of the OSD land on which the High School is sited.

With the additional artificial field now at the site, right next to the stadium, and NO limits on who can be allowed to use the fields, the frequency of use will **obviously** increase. OSD's internal policies are easily changed, and OSD has already shown it won't necessarily follow them anyway. The character, appearance, and livability of our residential zone has already been adversely affected by the OSD's piecemeal approach to expanding the sports facility at Olympia High School. If the City removes user restrictions for the facility, it will remove protections provided in Olympia's Municipal Codes for residential zones. I believe the

reasonable thing to do is to state clearly that the existing conditions on the Land Use will stay intact and perhaps also apply to the use of the site's additional artificial turf field. The rational for this is that the current conditions somewhat protect the nearby residents as required by City codes and (1) nothing has happened to substantially reduce the ODS impact to our residential zone, while (2) there have been changes to the Olympia High School, (additional classrooms, increased science lab space, increased music facilities, changes in parking, etc., and expected changes in local traffic) that will increase neighborhood impacts. And, (3) independent of the OSD, there is an increase of new housing and traffic in the area generally, so OSD's use of an additional artificial turf field will bring increased traffic as more users get scheduled for the additional field use. OSD's assertion that their proposed scrapping of a critical part of two Hearing Examiners' final ruling would have little or no adverse impact on our residential zone is insulting and clearly untrue. OSD's assertion that its internal policy (4260P(c) will be sufficient to protect the residential zone is equally untrue. OSD has often violated its own policy in the past.

In summary, two Hearing Examiners have ruled, in separate "final" decisions, that the condition on the OSD's Land Use Permit for the Ingersoll facility which restricts non-district and private user groups should remain intact. Additionally, the Hearing Examiner's ruling in 2013 states, that based on sited legal precedence, ("The matters previously decided in the Hearing Examiner's decision of May 28, 2004, have been finally decided and may not be re-litigated in this proceeding. Wenatchee Sportsmen Ass'n v. Chelan County, 141 Wn.2d (2000).") it cannot be relitigated.

I previously commented to OSD that I disagree with their DNS. I believe it should be withdrawn on the basis that it is incomplete, misleading and improperly executed. While Jennifer Priddy of the OSD claims that the current OSD proposal is a "Project" even though it has no physical aspects, only proposed change to regulatory language, the proposal actually fits into the "Non-Project" category precisely because it doesn't deal with physical changes to the property. As such, Section D of the SEPA checklist should have been completed and the environmental impacts resultant from increased frequency of use and increased periodic removal disposal and replacement of the artificial turf fields, should have been revealed. OSD did not complete the SEPA checklist properly and merely tossed out conjecture that there might be only marginal impacts, without any apparent study or data to support it, even though they are putting in a second artificial turf football/multi use sports field and want to have absolutely no restrictions on what user groups may be allowed to use the facilities.

Our family received a "Notice of Land Use Application and Meetings" dated September 23, 2020. I have real concerns regarding this latest proposal from Olympia School District (OSD).

Overview and History:

As one of the neighbors closest to the stadium to the east of the property, I have closely followed the stadium's multiple incremental expansions, and non-district user group access changes, over the 28 plus years I've lived next to the facility. Since the Stadium grew from what was originally a small natural grass facility serving only football for Olympia High School (OHS), to the huge year round facility it is today, in several piecemealed steps, there was never a Conditional Use Permit (CUP) established. OSD has refused requests for a CUP to be placed on the Stadium. In 2004, when OSD wanted to put in Artificial Turf, along with other upgrades to Ingersoll Stadium, which would expand the use of the facility from 100 events a year, to 500 events a year (a fivefold increase in frequency of use) this was sent to a Hearings Examiner. It was determined by the City's Community Advisory Committee and OSD that school use only needed around 100 events a year, so the approximate 400 remaining events could be rented out for non-district private use events. The Hearings Examiner "put conditions" on the Land Use Request to protect the "livability" of the densely and closely populated neighborhood that surrounds the Stadium on all sides, and is zoned Residential, since there was no CUP to address all that excess additional use. It's important to note that though the neighborhood around Ingersoll Stadium is zoned Residential, other Stadiums in the area, like North Thurston and Tumwater Stadiums, are zoned Mixed Use and/or Commercial. The Hearings Examiner's ruling of 2004 was not appealed by OSD, and the opposition agreed to a few concessions, in lieu of an appeal, including notifications to neighbors and interested parties, if OSD sought changes to the ruling, like expansion of nondistrict user groups, and this was agreed on by the City. Around that time an OSD official was quoted in the Olympian Newspaper as saying that he visualized

Ingersoll Stadium as becoming a Southwest Washington Regional Hub, and a real moneymaker. Through the years OSD has continued to work on this goal, from my observations.

In 2013 OSD sought to expand the non-district private user groups from what was allowed in the 2004 Hearing Examiner's ruling. The 2013 Hearing Examiner affirmed the decision of the 2004 Hearing Examiner, saying that decision was not appealed, and the decision was final. He gave law precedence, citing Wenatchee Sportsmen Association vs. Chelan County as his rational why the 2004 ruling could not be re-litigated. He stated in His 2013 decision "The matters previously decided in the Hearing Examiner's decision of May 28, 2004, have been finally decided and may not be re-litigated in this proceeding. Wenatchee Sportsmen Ass'n v. Chelan County, 141 Wn.2d (2000)". I assert the same situation should apply to this proposal regarding these proceedings. The 2013 Hearing Examiner's decision was also not appealed by OSD. Regarding Ingersoll Stadium, there have not been changes to justify reconsideration. This summer OSD added a whole second artificial turf field behind Ingersoll Stadium, and have already received permission to rent the second artificial field out to non-district private user groups. If Ingersoll Stadium restrictions on non-district user groups are lifted, this would allow a total of 1,000 events a year, and the majority of that use would NOT BE SCHOOL EVENTS, but non-district private events instead.

O.M.C. and SEPA

If the 2004 Hearings Examiner's protective restrictions are lifted on which non-district private user groups can have access to Ingersoll Stadium, and as OSD is requesting, it is opened up to all unlimited private user groups, we will see a huge expansion in frequency of use. In this residentially zoned area there will be a large increase in traffic and neighborhood parking issues, pedestrian challenges, noise and light pollution, as well as garbage and vandalism. If restrictions on OSD are lifted regarding who can have access to the stadium for non-school-district private use, I have no doubt that OSD will go to SPRC in short order to request changes to policy 4260P(C) as well, in their usual piecemealed way, which will remove other "livability" protections.

Regarding O.M.C. references; 18.04.020 Purposes

A. The general purposes of the residential districts contained in this chapter are as follows:

- **3.** To maintain or improve the character, appearance, and livability of established neighborhoods by protecting them from incompatible uses, excessive noise, illumination, glare, odor, and similar significant nuisances.
- The only place I could find reference to "Recreational Facilities" in the Olympia Municipal Code (OMC) was under 18.04.060 -Residential districts' use standards, T. Parks and playgrounds, 4. Conditional use requirements. In this reference, there are guidelines on "Recreational Facilities". This reference states "The Hearings Examiner shall approve recreational facilities only if the proposed facility will not have a significant adverse effect on the immediate neighborhood". It also states that such a facility should be properly sited and screened.
- In light of the fact that OSD plans to rent and loan the facility as a community recreational resource, separate from school use, I feel a City Hearing Examiner should be evaluating this not as school use, but instead as public private group use of a recreational facility, and the O.M.C. governing that type of use should apply.

SEPA—OSD acts as their own Lead Agency, Prepares their own environmental checklist, and of course came up with a DNS, kind of like the proverbial fox guarding the hen house. OSD did not take into consideration the large increase in frequency of use opening Ingersoll Stadium to all unlimited non-school users would bring. OSD also relied on a very flawed traffic study that was conducted in 2018 for a different project, and was not figuring in increased frequency of use for this user expansion.

Conclusions and concerns

• Two separate Hearings Examiners have already adjudicated this issue regarding non-district user groups at Ingersoll Stadium. The non-district user groups were restricted to a select limited group of youth sports groups in the Hearings Examiners ruling of 2004, and affirmed again in 2013. Neither ruling was appealed by OSD, and the Hearing Examiner in

2013 stated the decision of 2004 was final, and could not be re-litigated. He cited legal presidency for his findings. Nothing has changed since his decision that would justify reopening the issue.

• The City of Olympia Municipal Codes and their interpretation should protect residents from adverse impacts of this private user group expansion, even if the O.S.D. would rather ignore its responsibility in that regard. The neighborhood around Ingersoll Stadium is zoned residential, and what OSD is proposing is NOT educational use, but rather is private recreational use.

Considering the second artificial turf field that OSD has recently added, which will be open to non-school-district unlimited use, the potential for neighborhood impacts is huge. This is a school district trying to turn their recreational facilities into a public park facility, instead of an educational facility, in a residential zone. There will be significant increased traffic, parking conflicts in nearby neighborhoods, difficulty accessing main roads from feeder neighborhood streets, additional noise and light pollution, vandalism and garbage increases.

Please do not allow this "Ingersoll Stadium Use Restriction Modification" request. In reality it is a complete removal of a condition of use that the 2004 Hearings Examiner placed on his ruling to protect the livability of our residential neighborhood surrounding the Stadium. In the past prior to those "conditions" there were many instances of abuse to the neighborhood by OSD regarding Stadium use. Loud fundraisers, religious and other types of rallies, dog shows, adult and senior games, etc. That was before the increased use artificial turf, and the addition of a full second turf field would allow. Please protect our neighborhoods from this type of abuse. Everyone deserves some sanctuary in their own home. Ingersoll Stadium should be limited to school use, and the limited additional youth groups.

I have talked with the City's legal team and reviewed city code regarding impartiality of the Hearing Examiner. The code sections most applicable are OMC 18.82.080 A, which says: No City official, elective or appointive, shall attempt to influence the Hearing Examiner in any matter officially before the Hearing Examiner so as to constitute misconduct of a public office under RCW 42.20 or a violation of the Appearance of Fairness Doctrine. No member of the Council shall participate in any proceeding on appeal from a Hearing Examiner's decision if to do so would constitute a conflict of interest or violation of the Appearance of Fairness Doctrine.

We will coordinate with the Hearing Examiner to ensure that he feels he can act in an impartial manor. According to OMC 18.82.080 B: "The Hearing Examiner shall conduct all proceedings in a manner to avoid conflicts of interest or other misconduct and to avoid violations of the Appearance of Fairness Doctrine. If such conflicts or violations cannot be avoided in a particular case, the Hearing Examiner shall assign a Hearing Examiner pro-tem to act in the Hearing Examiner's absence."

Hi Jennifer --

At the "neighborhood meeting" re the OSD Ingersoll proposal, you kindly said that you would welcome additional questions. I have been held up by family affairs, but I do have some questions that I was unable to pose during the Zoom session.

- 1. I found the neighborhood meeting very helpful in clarifying potential impacts. I had assumed that the proposed change would result in far greater use of the stadium, but you said (if I heard correctly) that this is not true. I think you said that most of the reasonably assignable time was already being used, so that the change would mostly be a matter of reducing the use by some existing users, esp. Black Hills youth soccer, to make room for new users like lacrosse players.
- a. What do you consider reasonably assignable times/days?
- b. The existing limitations seem to focus stadium use on youth sports, which is consistent with the District's K-12 mission. Removal of these limitations would open the stadium to adult sports groups and really just about anyone for any purpose imaginable -- political rallies, religious revivals, auctions, etc. These are not consistent with the District's K-12 mission and in fact could supplant the use by youth sports groups that are. Why would the District want to do this?
- c. I recall that advocates for the proposed change have repeatedly said over the years that it is "for the children", but that does not seem to be the case. Does the district plan to favor youth sports over other uses? Or local sports organizations over out-of-county sports groups? If so, should this not be part of the Hearing Examiner decision?
- 2. The district has repeatedly stated that existing regulations regarding hours of use, sound system use, supervision, and etc. would not change (District Procedure 4260P(C) and possibly 4260A). However, my understanding is that these other regulations are OSD policies and can therefore be amended by the School Board. If the district's advocacy of its proposed policy change is based on this assurance that district regulations would not change, then it seems to follow that these other regulations should be part of the Hearing Examiner's decision.

Furthermore, these other regulations are only as good as their enforcement, so it seems imperative that the Hearing Examiner include penalties for failure by the district to enforce. There have been lapses in the past and are likely to be lapses in the future because enforcement is not a primary focus of school districts.

3. I understand that the heavy use by Black Hills is a result of a cooperative arrangement among youth soccer organizations. By having a a single coordinator for all clubs, they can avoid a situation where all clubs compete for and use all fields. This provides efficiency and stability, but it also results in each club focusing its use on a single field and thus appearing to be getting favored treatment. I just want to be sure that you are aware of this and avoid any misunderstandings of the situation.

I would appreciate your responses to these questions.
