**4.B**<u>17-1163</u>Approval of Resolution Adopting the 2018 Olympia Metropolitan Park<br/>District (OMPD) Budget

Parks, Arts & Recreation Associate Director Jonathon Turlove noted there were no changes to the proposed budget from last week's public hearing.

Boardmember Selby moved, seconded by Vice President Roe, to adopt the 2018 OMPD budget and authorize the Board President to sign the resolution. The motion carried by the following vote:
