**4.B** <u>18-0049</u> Election of President and Vice President for the Transportation Benefit District (TBD) Board

Boardmember Cooper nominated Boardmember Jones for President and Boardmember Gilman as Vice President.

Public Works Deputy Director Mark Russell presented the City's transportation needs and upcoming projects planned in 2018. Boardmembers asked clarifying questions.

#### Boardmember Selby moved, seconded by Boardmember Parshley, to approve

the resolution to adopt the 2018 Budget and recommend that the Olympia City Council amend its 2018 Capital Budget by adding \$95,000 to the transportation portion of the budget. The motion carried by the following vote:

Mr. Russell explained pavement ratings and noted project highlights in the 2017 annual report. Boardmembers asked clarifying questions.

Board Treasurer Debbie Sullivan explained that after \$1,5. million was set aside in the Capital Budget for the TBD, new figures estimate \$1.6 million will be collected. In order to make the updated amount available to the City of Olympia, the TBD Board may request the Capital Budget be amended to include the updated amount.

# Boardmember Cooper moved, seconded by Boardmember Parshley, to forward a recommendation to the Olympia City Council to increase the 2018 Transportation Benefit District Capital Budget from \$1,500,000 to \$1,595,000. The motion carried by the following vote:
