Preliminary Site & Landscape Plan: Recommend conditional approval with the following conditions to be addressed at the time of Detail Design Review:

1. All site features greater than 30" in height shall be shown on the elevation plans. Cut sheets with the specific model and design of the amenities shall be provided with the Detail Design Review packet (OMC 18.120.050, 18.16.080, and 18.110.020).

2. All proposed sign designs and sizes shall be shown on plans as well as indicating their anticipated location on the site plan (OMC 18.110.030 Connections & 18.120.110).
3. Cut sheets for each product intended to be installed in the pedestrian plazas shall be provided with the detail design review packet (OMC 18.110.050).
4. Cut sheets indicating the bike locker, bike rack, and bike cover models, sizes and colors shall be submitted with the Detail Design Review application submittal (OMC 18.050 & OMC 18.38.220(c)).
5. Signage at the entry of all bike parking locations shall be provided to help identify the intended user and use of the space (OMC 18.050 & OMC 18.38.220(c)).
6. Landscaping plans identifying the location of utility lines and the proposed placement of the plants shall be provided with the Detail Design Review submittal (OMC 18.110.180 & OMC 18.110.190).
7. Provide plans that show the methods of screening for all site utility features with the Detail Design Review packet. Utility boxes that exceed 30" above ground shall be shown on elevation plans (OMC 18.110.180 & OMC 18.110.190).
8. Investigate repositioning or reorienting the trash enclosure so that it is not as visible from State Street. If relocation is not feasible, consider alternatives such as landscaping and screening mechanisms to help mitigate visibility of the enclosure.

CONDITIONS OF APPROVAL

1. Site and Landscape Design: Approve with the following conditions, to be addressed at the time of engineering permit review:
 - a. Provide additional landscaping, modify the design of the planting beds, and/or provide other pedestrian amenities on the east side of the building to further define the pedestrian area and create visual interest.
 - b. Submit a final landscape plan prepared in accordance with OMC 18.36, and addressing the following items:
 - i. Provide trees along Columbia Street; locate to maintain visibility of the transit shelter by approaching busses; and
 - ii. Include images and manufacturer's information for the landscape containers.
2. Building Design: Approve with the following conditions, to be addressed at the time of building permit review:
 - a. Replace the solid waste roll-up door on the east elevation with one that matches the garage door, or otherwise meets street wall requirements in OMC 18.110.090 and pedestrian "A" street standards in OMC 18.16.
 - b. Reconsider light tones; for example, use warm LED fixtures in the garage.
 - c. Provide soffit on the north elevation of the garage opening to reduce light to the outside.
3. Approve materials and colors as presented at the DRB meeting.
