Issue:

Whether to approve a Resolution authorizing the purchase and dedication of right-of-way across and through the Kaiser Heights property for the future Kaiser Road Extension.

Background and Analysis:

The City of Olympia is negotiating a Real Estate Purchase and Sale Agreement to acquire the Kaiser Heights property from Wonderland Holdings, LLC for public open space. The Comprehensive Plan identifies a network of future streets needed in the next 20 years as our community grows. One of those street connections in west Olympia is along the boundary of this property, extending Kaiser Road to Black Lake Boulevard. It is prudent to establish the right-of-way for this future street with the purchase of the property.

The right-of-way needed for the future Kaiser Road Extension is 6.47 acres, more or less, through

the property being acquired by the City from Wonderland Holdings. Public Works staff recommends using Transportation Capital Improvement Program funding in the amount of \$94,895 towards the City's purchase of the Kaiser Heights property for purchase of the portion of property needed for future public right-of-way.

Neighborhood/Community Interests (if known):

There is community interest in preserving and acquiring the area commonly referred to as Kaiser Heights as open space and for parks use. The future Kaiser Road Extension project would build a road along the boundary of this property.

Options:

- 1. Approve the Resolution to use Transportation Capital Improvement Program funding to purchase a portion of the Kaiser Heights property for future right-of-way required for the Kaiser Road Extension. Upon acquiring title to the property, the City will promptly file and record with the Thurston County Auditor a Deed for Right-of-way Dedication for future roadway purposes.
- 2. Do not approve the use of Transportation Capital Improvement Program funding to purchase a portion of the Kaiser Heights property for future right-of-way required for the Kaiser Road Extension. Purchasing right-of-way in the future will be more expensive and require a more complicated real estate transaction.

Financial Impact:

Funds are available in the Transportation Capital Improvement Program to purchase the right-of-way needed for the future Kaiser Road Extension.
