Written statements must be received prior to the public hearing. They can also be submitted by e-mail to the staff contact listed above up to two hours prior to the public hearing. All public comments previously submitted are also provided to the Hearing Examiner for consideration.

**SEPA Threshold Determination:** The lead agency for this proposal has determined that this action is not likely to have a significant adverse impact upon the environment. Therefore, an Environmental Impact Statement is not required under RCW 43.21C.030(2)(C). The environmental review and SEPA threshold determination of this proposed action are based


upon the environmental checklist and related information on file with the City. This information is available to the public on request.

This DNS is issued under Washington Administrative Code 197-11-340. The applicant shall not begin work until after the appeal deadline has expired and any other necessary permits have been granted.

**Comments Deadline: 5 p.m., March 27<sup>th</sup>, 2026.** All comments regarding this Determination of Non-Significance (DNS) should be directed to the SEPA Official at the address above. If conditions are added, deleted or modified during or following the 14-day comment period, a revised threshold determination will be issued.

**Appeal Deadline: 5 p.m.; April 3<sup>rd</sup>, 2026.** Pursuant to RCW 43.21C.075(3) and Olympia Municipal Code 14.04.160(A), this DNS may be appealed by any agency or aggrieved person. Appeals must be filed with the Community Planning and Economic Development Department at the address above within twenty-one (21) calendar days of the date of issue. Any appeal must be accompanied by an administrative appeal fee.

**Decision:** Upon request, you will be provided with a copy of the decision regarding this project. Anyone who does not agree with the decision will have an opportunity to file an appeal of the decision. Email the lead planner to become a party of record and receive project notices.
